



The Super Easter Egg Hunt 2019

Super Food Plaza customers who shop between April 12th and April 21st and use their Bonus Card at the cash register with a minimum purchase of Afl. 50,- will automatically participate to win a ticket to participate in the Super Easter Egg Hunt 2019. Every day during mentioned period, our (POS) system will randomly select 3 instant winners at the cash register. The winners will receive a t-shirt and an invitation letter for the Super Easter Egg Hunt event.

On Monday, April 22nd at 4pm, the Super Easter Egg Hunt event will take place at Super Food. The 30 participants, accompanied by a maximum of 2 supporters will be allowed inside the supermarket. The participants will have a total of 30 minutes to hunt for eggs and win big prizes.

The Super Easter Egg Hunt Terms and Conditions

1. Only Super Food Bonus Card holders are eligible to participate in this campaign.
2. Winners must be 18 years or older to participate.
3. Winners must be able to attend the Super Easter Egg Hunt event on April 22nd at 4pm to participate. No other date can be set to accommodate participants.
4. Participants must bring their invitation letter, photo ID and wear the Super Easter Egg Hunt t-shirt during the event.
5. Only the winner himself/herself can participate in the Easter Egg Hunt, no stand-ins allowed.
6. A short briefing will be given prior to the start of the egg hunt for safety reasons.
7. All participants will start with the egg hunt at the same time. The sound of a horn will signal the start and the end of the Egg Hunt.
8. Only the Super Food store area is permitted as hunt area.
9. The number of eggs that a participant may find is unlimited.

10. 1 prize egg will be deducted from participant for each broken or damaged product during the egg hunt.
11. After the egg hunt, each winner must take his/her eggs to the counter to claim the prize corresponding to each egg.
12. No pushing or shoving is allowed during the egg hunt, any participant who displays aggressive behavior will be disqualified from the event and will not be able to claim any prizes.
13. The Super Easter Egg Hunt participants grant Super Food Plaza the right to use images of the event for promotional purposes on in-store screens, newspapers, website and social media for a period of two years.
14. In case of any misunderstandings that may arise related to the Super Easter Egg Hunt campaign, the decision of Super Food management is final and must be accepted by participants.
15. The Super Easter Egg Hunt participants accept the risk of running through a grocery store and assume responsibility for any accidents that may arise during the hunt and release Super Food Plaza from any damage or injury claims.
