



TERMS AND CONDITIONS

Super Food Aruba Celebrate & Win Campaign 2018

1. Campaign Period

The Super Food Plaza Christmas campaign (Celebrate & win) is organized by Super Food Plaza Aruba and runs from December 1st 2018 until December 31st 2018.

2. Eligibility

- 2.1. This Campaign is open to all existing Super Food Bonus Card members with a permanent address in Aruba ("Eligible Customer").
- 2.2. Super Food bonus card holders who make a purchase of Afl 50,- or more, within the campaign period, will participate instantly.
- 2.3. Participating stores are: Super Food, Bliss, Jack's Café Aruba, Casa, Intertoys and Cheers
- 2.4. The following entities / individuals are NOT BE ELIGIBLE to participate in this Campaign:
 - (a) Super Food Bonus card holder who passed away before the draw date.
 - (b) Individuals under 18 years of age.
 - (c) Super Food employees and their immediate family are not eligible to participate in this promotion, neither the employees of any other participating stores.
 - (d) Individuals who are not Super Food Bonus Card holders.

3. Campaign Mechanics

- 3.1 Customers must present and scan their bonus card at checkout/cashier.
- 3.2 Once the transaction reaches Afl 50,-, you are participating to instantly win one of the prizes
- 3.4 When the cashier hits the subtotal button, the screen will show if, and what prize you've won.
- 3.5 The prizes are: Afl. 25,- , Afl. 50,- and Afl. 100,- gift voucher, 50000 Bonus Points and 100000 Bonus Points.

4. Claim of Prizes

- 4.1. The gift voucher prizes must be claimed by the bonus card holder within 30 days from the date of issue and Super Food Aruba will not accept any claim after the said period.
- 4.2. Winners are deemed to give up their rights if they fail to claim their prizes within the specified period.
- 4.3. Winners are required to present a valid Identification Card when claiming their prize.
- 4.4. Winners of 50,000 and 100,000 bonus points will keep these points until they choose to redeem them. The bonus points do not expire.
- 4.5. The following terms and conditions apply only to the winner of the first prize, a 10kW solar panel system for your home.
 - All Super Food Plaza's Bonus Card Holders are eligible to win the 10kW solar panel installation.
 - The winner will be notified instantly at the cash register.
 - Camro N.V will arrange for an in-home consultation to view the home's situation regarding its electrical installation and the capacity of it to support a solar panel installation.
 - If the winner opts not to accept the solar panel installation prize, he/she can opt for 1,500,000 bonus points on his/her bonus card.
 - Winner must meet all requirements of Camro N.V's installation policy.
 - All Camro N.V's usual performance, manufacturer, and installation warranties are included.
 - The installation site must be a sound structure constructed with the city permit and approval.
 - If the home of the winner requires additional investment to support a solar panel installation beyond the set Afl. 35.000 total budget of this prize, the winner may opt to pay for the difference or choose the bonus points option.
 - Elmar places its own terms and conditions regarding solar panel installations (Elmar Solar Policy) and the winner must abide by these terms and conditions to have the system installed. The winner is also responsible for paying Elmar for usage of its electrical grid.
